Taxpayer Granting Limited Power of Attorney

Purpose – This form satisfies specific statutory requirements for taxpayers to designate agents to represent them before the Texas Comptroller of Public Accounts. See Texas Tax Code Section 111.023. You may use this form to grant authority to an attorney, accountant or other representative to act on your behalf for all tax-related matters. **If you choose to use this form, provide all the information requested; we will return incomplete forms.**

If no specific date of expiration is selected, I understand that the Comptroller's office may act under this limited power of attorney until the Comptroller's office receives written notice of my revocation. My Agent has the power and authority to do and perform every act necessary and proper in the exercise of any of the powers described above, as fully as I could do personally. This includes the right to request and receive confidential information. I acknowledge that use of the named Agent does not relieve me, as the taxpayer or officer, director or employee of the taxpayer, of my responsibilities when filing accurate reports and returns. I further acknowledge that I am ultimately responsible for the accuracy of any reports or returns filed on my behalf by my Agent.

If signing as an officer, director or employee of the taxpayer, I certify that my duties include administering the taxpayer's rights and responsibilities with the Comptroller's office and that I have authority to execute this limited power of attorney.

If the taxpayer or officer, director or authorized employee of the taxpayer fails to date the signature on Page 2 of this form, then the Comptroller's office will not accept the form.

Only the following individuals may authorize the release of a taxpayer's confidential tax and/or audit information, or to access electronic services for <u>all tax types</u>:

- Officers, directors, members, general partners and managers who are individuals, not other legal entities, listed on a taxpayer's most recently filed Public Information Report;
- · General partners or trustees who are individuals, not other legal entities, listed on a taxpayer's most recently filed Ownership Information Report;
- Other individuals, authorized in accordance with the taxpayer's governing documents, must provide written proof of such authorization with the LPOA.

INSTRUCTIONS FOR COMPLETING THE LIMITED POWER OF ATTORNEY FORM FOR CRUDE OIL AND NATURAL GAS TAXES

This Limited Power of Attorney form is required to grant authorized access to electronic systems and to receive confidential information for Crude Oil and Natural Gas tax accounts.

Attorney, Accountant, Firm or Other Representative Appointed to Act on Behalf of the Taxpayer (Agent)

- All fields are required except Period(s)/Report year(s). This information should be included for the specific items in the form for accessing
 account data for Crude Oil and Natural Gas Production taxes.
- Tax type(s)/Subtype(s)/Fee(s):
 - Unless specified with a limitation in this field, access will be provided to both purchaser and producer accounts (where applicable) for crude oil and natural gas tax types that are selected in the checkboxes below.
 - Example: If a taxpayer has both a Natural Gas Producer and a Purchaser account, access will be provided to both when the "To access account data for natural gas production taxes." checkbox is selected. To limit this to only a producer account, use this field by writing "natural gas producer".

Access Account Data for Crude Oil and Natural Gas Production Taxes Checkboxes

- Taxpayer must select the checkboxes that correspond with granting of the appropriate account access to data for each tax type.
 - These identify the reporting periods that may be accessed or allowed to report for Crude Oil and Natural Gas tax.
 - · Period must be included as YYMM (monthly filers) or YY (annual filers).

Signature Effective Date

- This section determines the timeframe when an authorized agent can access or transact business on the taxpayer's account.
- A date must be provided to revoke access after a specific date or select the checkbox to allow activity until the LPOA is revoked in writing.
- To revoke an existing LPOA, the taxpayer may send an email to congtax@cpa.texas.gov.

Signature and Contact Information

- · All fields are required and must represent the signors information.
- Signature date may not be greater than 12 months prior to submission.
- Other individuals, authorized in accordance with the taxpayer's governing documents, must provide written proof of such authorization with the LPOA.
